

13. Rights of the data subject	Under the EU's GDPR (2016/679) the data subject has the following rights:
<b>,</b>	Right of access to their data. The data subject has the right to receive from the controller confirmation on whether or not the personal data concerning them is processed. The data subject has the right of access to the data. A fee may be charged for the right of control. The data subject's request for control may be refused, if the requests are manifestly unfounded or unreasonable and especially if made repeatedly. (Articles 12 and 15)
	The right to rectification. The data subject has the right to demand rectification of inaccurate personal data concerning them. (Article 16)
	The right to erasure. With certain restrictions specified in the General Data Protection Regulation, the data subject has the right to have the controller erase the personal data concerning him or her. (Article 17)
	The right to restriction of processing. With certain exceptions specified in the General Data Protection Regulation the data subject has the right to request the controller to restrict the processing of personal data concerning him or her. (Article 18)
	The right to data portability. The data subject has the right to receive the personal data that he or she has provided to a controller in a machine readable format, when the processing is based on consent and is automated. (Article 20)
14. Automated decision making	The data subjects of the register are not subjected to automated decisions.
